- 4.1.2 - "Ordinary member" shall be the person (who may also be a Levy member) who is growing avocados within New Zealand or, in the opinion of the Executive, intends so to do and is nominated as an Ordinary member by the holder of a PPIN PROVIDED THAT where that holder has several PPINs which relate to one avocado orchard encompassed in one rating assessment by its territorial local authority, then one only Ordinary member shall be nominated by that holder.

**Levy Member Nomination:****Rules as stated in the Export marketing strategy**

- 4.1.1 - "Levy member" shall be any person who has in the preceding financial year of the Association been primarily liable to pay a Commodity levy to the Association and has so paid in respect of avocados produced in New Zealand. Payment of the Commodity Levy by a collection agent shall be deemed to be payment by the person primarily responsible. Where a Commodity Levy has been paid on behalf of a partnership or corporate body that payer shall nominate one natural person to be its Levy member of the Association.
- 14.5.2 - Each Levy member shall have one vote for each 1,000 tray equivalents of production (rounded up) based on the highest such production in one of the two years ending 30 April preceding such vote.
