1. How many grades of avocado oil should there be? What quality standards do we set for each grade?

Type of Avocado Oil	Conventional	Certified Organic	Free Fatty Acid
Extra Virgin	✓	✓	≤ 0.8%
Crude	✓	✓	> 0.8%
Refined	✓	✓	0.1% max





Avocado Oil quality reflects its value

---- it's critically important to have highest oil quality Regardless of whether it's Extra Virgin or Crude:

3 factors determine Avocado Oil quality:

- 1. Quality & capability of machines.
- 2. skill of the oil makers.
- 3. quality of your avocado.

Certified Organic
Avocado achieve highest
values in fresh fruit & oil
markets.

High quality equipment is so important.

E.g. 10.5% vs 10% oil yield might be worth an extra \$3,000+ per day





Notes: Work 24/7, or as required. No need to work @ full capacity

- # Locate more lines side-by-side to expand
- # Larger production lines, are more robust, have a longer life expectancy, & achieve much better economies-of-scale.







Minimum standards for avocado oil machines? Should every line include a:

- Fruit washing system and Quality Control Conveyor and DeStoner to remove seed & skin
- Pumps after the Vertical Separator.











4. How can we fund the International Avocado Oil Council?

The least controversial funding method is for Avocado Oil producers to pay a very small tax, or levy, on their output. Other IAOC members to pay an annual subscription fee.

The secret for success is that the Council must provide incredibly good value for money.
